ORDINANCE NO. 2020 - Z AN ORDINANCE DISCONNECTING REAL PROPERTY FROM THE CORPORATE LIMITS OF THE CITY OF MONTICELLO

PREAMBLE:

WHEREAS, on the 21st day of May 2019, Ella Dean Randall filed a Municipal Disconnection Petition to disconnect out of the City of Monticello of the following described real property located in San Juan County, Utah:

Property Owner: Dean Randall <u>Parcel No. A33240310003/ N00 degrees 15'00''E</u> between the E1/4 corner and the northeast corner of Section 31, Township 33 South, Range 24 East, SLB&M.

WHEREAS, on May 21, 2019, at 7:00 p.m., the Monticello City Council held a public hearing for the purpose of public input into the petition for Municipal Disconnection; and,

WHEREAS, the City of Monticello having considered all public comments and all other relevant information, has determined that good cause exists for the granting of the disconnection petition and disconnecting the above real property from the corporate limits of the City of Monticello and that such disconnection would not be detrimental to the interests of the property owners or to the public interests.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MONTICELLO:

The above described real property is hereby disconnected from the corporate limits of the City of Monticello and made separate thereof and authorizes the execution of any and all documents necessary to give effect to this ordinance.
