ORDINANCE NO. 197

ORDINANCE ANNEXING SPECIFIC PROPERTY TO ELSINORE, UTAH

WHEREAS, the owner of certain real property described below, desires to annex such real property to Elsinore, Utah, said owner, Rick Larsen, petitioner, filed a petition with the Town Clerk of Elsinore, Sevier County, State of Utah requesting that such property be annexed to the corporate boundaries of Elsinore Town; and

WHEREAS, said real property consists of approximately 1.73 acres and lies contiguous to the corporate boundaries of Elsinore, Utah; and

WHEREAS, said owners have caused a petition to be filed with the Town Clerk together with an accurate plat of the real property which was made under the supervision of a licensed surveyor; and

WHEREAS, Elsinore Town Council accepted the petition for annexation; and within 30 days the Town Clerk reviewed the petition and certified that the petition meets the requirements for annexation as provided by Utah State Law (Subsections 10-2-408(2), (3), and (4)); and

WHEREAS, a notice was published once a week for three successive weeks, beginning no later than ten days after receipt of the notice of certification, in a newspaper of general circulation the area proposed for annexation and the unincorporated area within half mile of the area proposed for annexation as provided by Utah State Law (Subsection 10-2-406); and

WHEREAS, within 20 days of receipt of the notice of certification, written notices were mailed to the affected entities as provided by Utah State Law (Subsections 10-2-406(1) (b)); and

WHEREAS no protests to the annexation petition were filed during the period specified.

NOW, THEREFORE, pursuant to Section 10-2-407, Utah Code, the City Council of Elsinore, Utah, hereby adopts and passes the following:

BE IT ORDAINED BY THE CITY COUNCIL OF ELSINORE, UTAH, AS FOLLOWS:

ORDINANCE NO. 196 ANNEXING CERTAIN REAL PROPERTY AND EXTENDING THE CORPORATE LIMITS OF ELSINORE, UTAH.

The real property more particularly described in Paragraph 1, below, is hereby annexed to Elsinore, Utah and the corporate limits of Elsinore, Utah, are hereby extended accordingly.

TAX ID 4-318-27

BEGINNING AT A POINT WHICH IS LOCATED WEST 323.46 FEET AND SOUTH 269.14 FEET FROM THE CENTER OF SECTION 28, TOWNSHIP 24 SOUTH, RANGE 3 WEST, SALT LAKE BASE AND MERIDIAN SAID POINT ALSO BEING ON THE NORTH RIGHT-OF-WAY LINE OF STATE HIGHWAY 258 AND IS THE SOUTHEAST CORNER OF TAX PARCEL 2-E4A-4 AND RUNNING THENCE NORTH 00°08'43" WEST ALONG THE EXISTING TOWN BOUNDARY, THE EAST LINE OF TAX PARCELS 2-E4A-4 AND 2-E4A-3 750.50 FEET TO THE NORTHEAST CORNER OF TAX PARCEL 2-E4A-3 AND TO A POINT ON THE SOUTH RIGHT-OF-WAY LINE OF 100 NORTH STREET; THENCE ALONG SAID SOUTH RIGHT-OF-WAY LINE THE FOLLOWING TWO (2) COURSES: NORTH 84°49'11" EAST 21.48 FEET AND NORTH 87°52'50" EAST 78.65 FEET; THENCE SOUTH 00°08'43" EAST 753.52 FEET TO A

POINT ON THE NORTH RIGHT-OF-WAY LINE OF STATE HIGHWAY 258; THENCE SOUTH 88°56'56" WEST ALONG SAID NORTH RIGHT-OF-WAY LINE, 100.01 FEET TO THE POINT OF BEGINNING.

CONTAINING 1.73 ACRES.

1. The zoning map of Elsinore Town shall be amended to include the real property described in Paragraph 1 above. The real property described in Paragraph 1, above, shall be classified as being in single

family residential (Ag - R1), in accordance with the General Plan for Elsinore, Utah and provisions the Town's Land Use Ordinance and Section 10-9-406(1) of the Utah Code Annotated, 1953, as amended.

- 2. A certified copy of this Ordinance and an original plat setting forth the property so annexed shall be filed with the County Recorder of Sevier County, Utah by the Town Clerk.
- 3. This Ordinance shall become effective upon adoption and passage by the Town Council. A copy of the Ordinance and plat shall be deposited in the Office of the Town Clerk.
