## ORDINANCE 1-2020 HUNTINGTON CITY

AN ORDINANCE CREATING THE "HUNTINGTON CITY COMMUNITY REINVESTMENT AGENCY" UNDER TITLE 17C OF THE UTAH CODE.

WHEREAS, Huntington, Utah (the "City") has determined that it is in the best interests of the City to undertake community development, economic development and/or urban renewal in such areas of the City as may become necessary or desirable;

WHEREAS the City intends draft community development, economic development and/or urban renewal project undertaken within the City be carried out in accordance with the provisions of Title 17C of the Utah Code, the "Limited Purpose Local Government Entities - Community Reinvestment Agency Act" as amended (the "Act"); and

WHEREAS Section 17C-1-201.5 of the Act authorizes the legislative body of a community to create a community reinvestment agency for the purposes of undertaking or promoting community development, economic development, and/or urban renewal within the geographic boundaries of tire agency, which shall be coterminous with the boundaries of the community creating the agency, or as otherwise provided by the Act.

THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF THE COUNTY OF EMERY, UTAH:

Section 1. Pursuant to the provisions of Section 17C-1 -201.5(1) of the Act, the City creates a community reinvestment agency (tire "Agency"), contingent upon the issuance by the Utah Lieutenant Governor of a certificate of creation under Section 67-la-6.5 of the Utah Code.

Section 2. The official name of the Agency is the "Huntington City Community Reinvestment Agency

Section 3. The geographic boundaries of the Agency are and will always be coterminous with the geographic boundaries of the incorporated area of the City. Any change in the boundaries of the City after the effective date of this Ordinance will automatically, and without any further action required, constitute a similar change in the boundaries of the Agency.

Section 4. Upon creation, the Agency will be vested with all the powers set forth in the Act and as otherwise provided by law.

Section 5. The governing body of the Agency will be a Board consisting of the members of the city council, and the mayor acting as the executive director. Any change in the composition of the city council or mayor will automatically, and without any further action required, constitute a similar change in the composition of the Agency Board.

Section 6. Within ten days of the adoption of this Ordinance, the community legislative body will cause to be prepared and filed with the Utah Lieutenant Governor's office a notice of impending boundary action (the "Notice") and a final local entity plat (the "Plat") both as required by Section 17C-I-201.5(2)(a) of the Act. The Plat must comply with the requirements of UCA §67-la-6.5(3). The appropriate officials of the County are authorized and directed to sign and seal both the Notice and the Plat upon their proper preparation.

Section 7. Upon the issuance by the Utah Lieutenant Governor's office of a Certificate of Creation under UCA §67-la-6.5, the Agency will be created and incorporated, and the City will submit or cause to be submitted to the County Recorder the original Notice, the original Plat, the original Certificate of Creation, and a certified copy of this Ordinance.
