#### ORDINANCE No. A01-21

### AN ORDINANCE ANNEXTING PROPERTY KNOWN AS THE SWIFT CREEK ANNEXATION

WHEREAS, pursuant to Utah Code Ann. § 10-2-418, the City Council may

annex an existing island or peninsula of unincorporated land by first adopting a

resolution expressing its intent to annex an unincorporated island or peninsula;

WHEREAS the City Council adopted Resolution No. 20-25, expressing intent

to annex an unincorporated island or peninsula known as the Swift Creek Annexation;

WHEREAS, as required by Utah Code Ann. § 10-2-418(2)(b)(ii), one or more municipal type services have been provided to the area proposed for annexation for at least one year, namely fire and emergency medical services, and the area has a population of fewer than 800 residents;

WHEREAS, after required public notice, the City Council held a public hearing on the proposed annexation; and

WHEREAS the City Council has not received written protests to the annexation, at or before the hearing, by the owners of private real property that is located in the proposed annexation area, covering a majority of the total private land area within the entire area proposed for annexation, and equal in value to at least one half the value of all private real property; and

WHEREAS the City Council desires to approve the Swift Creek Annexation (attached as Exhibit) and add the territory described in therein to the incorporated area of Spanish Fork City;

**NOW, THEREFORE,** be it ordained by the Spanish Fork City Council as follows:

**Section 1.** Annexation. The boundaries of Spanish Fork City are hereby extended so as to include and incorporate within the said City limits the following described land located in Utah County:

Swift Creek Annexation Plat, attached hereto as an Exhibit

**Section 2.** Zoning Classification. Pursuant to Spanish Fork Municipal Code § 15.3.08.030(E), the zoning classification for the annexation shall be R-1-15.

Section 3. Not Part of Municipal Code. This ordinance shall not become part of the Spanish Fork Municipal Code.

**Section 4. Effective Date.** This ordinance shall be effective twenty days after passage and publication.


