ORDINANCE 20321

AN ORDINANCE ANNEXING AND ZONING PROPERTY KNOWN AS THE BROADHOLLOW ESTATES ANNEXATION

WHEREAS a petition has been filed with the Salem City Council by Diamond Creek

Development, LLC, on behalf of Richard and Audra Morley, the owners of property representing

a majority of the assessed valuation of real property hereinafter described, which property lies contiguous to the corporate limits of Salem City;

WHEREAS the petitioner has also submitted an accurate plat of said territory and have filed the same in the office of the Salem City Recorder;

WHEREAS the Salem City Recorder has certified that the petition complies with the requirements of Utah Code Ann. §10-2-403, as they pertain to annexations;

WHEREAS Salem City accepted the petition for further consideration and certified it to the Utah County Boundary Commission, pursuant to Utah Code Ann. §10-2-405, on September 16, 2020;

WHEREAS publication of the certification took place in the *Payson Chronicle*, a paper with local circulation in Salem City, on December 16, 2020, December 23, 2020, and December 30, 2020;

WHEREAS no valid protests were received concerning the annexation petition;

WHEREAS a public hearing was held before the Salem City Council on Wednesday, January 20, 2021, pursuant to Utah Code Ann. §10-2-407, with notice having taken place in accordance with said section;

WHEREAS, at the public hearing, support for the annexation was voiced and discussion concerning zoning of the property was conducted; and

WHEREAS, following the public hearing, the Council found there are no SESD facilities in the area;

NOW THEREFORE, be it ordained and enacted by the Salem City Council as follows:

Section 1. Annexation. The boundaries of Salem City are hereby extended so as to include and incorporate within the said City limits the following described land located in Utah County, Utah:

COMMENCING AT POINT ON THE EXISTING SALEM CITY BOUNDARY, SAID POINT BEING LOCATED SOUTH 89°39'17" WEST 199.11 FEET ALONG THE SECTION LINE AND NORTH 195.37 FEET FROM THE SOUTHEAST CORNER OF SECTION 1, TOWNSHIP 9 SOUTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN; THENCE ALONG SAID SALEM CITY BOUNDARY THE FOLLOWING NINE (9) COURSES: NORTH 89°13'25" WEST 9.22 FEET, NORTH 00°18'12" WEST 72.55 FEET, ALONG THE ARC OF A 853.18-FOOT RADIUS CURVE TO THE RIGHT 226.95 FEET, THROUGH A CENTRAL ANGLE OF 15°14'28", WHICH CHORD BEARS N 07°19'04" E 226.28 FEET, NORTH 14°56'15" EAST 223.07 FEET, ALONG THE ARC OF A 787.21-FOOT RADIUS CURVE TO THE LEFT, THROUGH A CENTRAL ANGLE OF 15°26'09", WHICH CHORD BEARS N 07°13'07" E 211.44 FEET, NORTH 00°29'53" WEST 287.68 FEET, EAST 0.41 FEET, NORTH 00°24'55" WEST 287.20 FEET AND NORTH 00°29'53" WEST 32.19 FEET; THENCE NORTH 89°17'19" EAST 587.08 FEET, THENCE SOUTH 00°03'00" EAST 983.67 FEET; THENCE SOUTH 28°36'59" WEST 13.00 FEET; THENCE SOUTH 84°46'51" WEST 487.68 FEET; THENCE SOUTH 00°29'53" EAST 301.07 FEET; THENCE NORTH 89°10'36" WEST 140.14 FEET; THENCE NORTH 88°15'07" WEST 57.36 FEET TO THE POINT OF BEGINNING.
