CERTIFICATE OF ANNEXATION

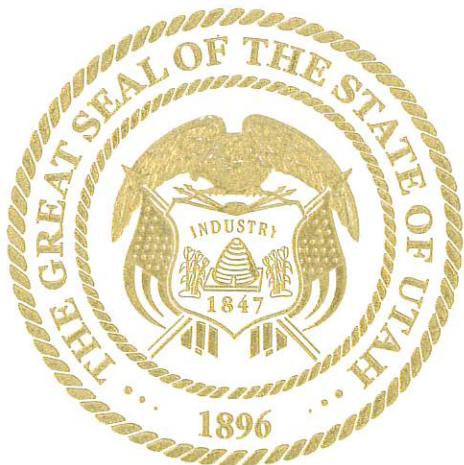

RESOLUTION NO. 05-2021

A RESOLUTION OF THE GOVERNING BOARD OF THE BONA VISTA WATER IMPROVEMENT DISTRICT ANNEXING REAL PROPERTY IN PLEASANT VIEW

WHEREAS, Bona Vista Water Improvement District ("District") is an improvement district duly organized and existing under the laws of the State of Utah; and

WHEREAS, a petition has been filed by GoeGoe Pharmaceutical Co., to have real property (parcel numbers 19-016-0033, 19-016-0034, and 19-016-0155) annexed into the District; and

WHEREAS, the Board certified the petition and the proposed annexation has been noticed in accordance with state law; and

WHEREAS, the Board finds approving this annexation is in best interest of the District;

NOW THEREFORE, be it resolved by the Board of Trustees of the Bona Vista Water Improvement District, that the following real property is hereby annexed into the District and shall receive culinary water under the same fees, rules, and regulations applicable to the District.

BEGINNING AT A POINT ON THE WESTERLY RIGHT OF WAY LINE OF PARKLAND BOULEVARD AND THE NORTHEAST CORNER OF LOT 13 OF PARKLAND BUSINESS CENTER SUBDIVISION PHASE 1, RECORDED JUNE 3, 1998 AS ENTRY NO. 1549557 IN BOOK 47 AT PAGE 22, AT THE OFFICE OF THE WEBER COUNTY RECORDER, SAID POINT BEING SOUTH 88°10'10" WEST 1039.47 FEET ALONG THE QUARTER SECTION LINE AND NORTH 00°42'24" EAST 115.84 FEET FROM THE CENTER QUARTER CORNER OF SECTION 25, TOWNSHIP 7 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, AND RUNNING THENCE NORTH 89°17'36" WEST 322.44 FEET ALONG THE NORTHERLY LINE OF SAID LOT 13 TO A POINT ON THE WEST LINE OF PARCEL 3 OF WEBER COUNTY SURVEY MAP NO. 1289; THENCE NORTH 01°11'48" EAST 444.54 FEET; THENCE NORTH 00°40'51" EAST 2147.82 FEET ALONG SAID WEST LINE OF PARCEL 3 TO A POINT ON THE SECTION LINE; THENCE SOUTH 89°31'23" EAST 68.07 FEET ALONG SAID SECTION LINE TO A POINT ON THE WESTERLY RIGHT OF WAY LINE OF THE OREGON SHORT LINE RAILROAD; THENCE SOUTH 25°53'49" EAST 1906.31 FEET ALONG SAID WESTERLY RIGHT OF WAY LINE TO THE NORTHEAST CORNER OF LOT 1 OF FINAL TWO SUBDIVISION, RECORDED MARCH 30, 2015 AS ENTRY NO. 2728214 IN BOOK 77 AT PAGE 13, AT THE OFFICE OF THE WEBER COUNTY RECORDER; THENCE ALONG SAID LOT 1 THE FOLLOWING TWO (2) COURSES: 1) SOUTH 64°58'59" WEST 169.23 FEET; 2) SOUTH 00°42'24" WEST 735.41 FEET TO A POINT ON THE NORTHERLY RIGHT OF WAY LINE OF 2775 NORTH STREET; THENCE ALONG SAID NORTHERLY RIGHT OF WAY LINE AND SAID WESTERLY RIGHT OF WAY LINE OF PARKLAND BOULEVARD THE FOLLOWING FOUR (4) COURSES: 1) NORTH 89°17'36" WEST 369.68 FEET; 2) NORTH 00°42'24" EAST 35.50 FEET; 3) NORTH 89°17'36" WEST 80.00 FEET; 4) SOUTH 00°42'24" WEST 114.78 FEET TO THE POINT OF BEGINNING.
