ORDINANCE 04 08 21

AN ORDINANCE ANNEXING CERTAIN REAL PROPERTY INTO CASTLE DALE CITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Castle Dale City Council received a petition to annex certain real property described herein on February 12, 2021; and

WHEREAS, the petition for annexation has been accepted by resolution of the Castle Dale City Council and certified by the Castle Dale City Recorder in accordance with law; and

WHEREAS, a notice of the proposed annexation has been published and sent to affected entities; and

WHEREAS, no protests have been received from property owners or affected entities; and

WHEREAS, the Castle Dale City Council finds that it is in the best interest of the City and its residents to annex the area proposed for annexation and that the City is capable of providing municipal services to the area.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Castle Dale City Council as follows:

Section 1. PURPOSE

The purpose of this ordinance is to annex certain real property into Castle Date City in response to a valid petition from owners of private land within the area proposed for annexation that is at least one half the value of all the private land in the proposed annexation and that covers a majority of the land proposed for annexation

Section 2. CLASSIFICATION

This is a noncode ordinance

Section 3. GENERAL PROVISIONS

Pursuant to the receipt of a valid petition, certification by the Castle Dale City Recorder, acceptance by the Castle Dale City Council and the completion of all statutory requirements prescribed by Utah State law, the following described real property is hereby annexed into the City of Castle Dale.

BOUNDARY DESCRIPTION:

Beginning at a point which is located N 89°44'34" E, 566.00 feet along the Section Line and N 00°46'31" W, 33.00 feet from the Southwest Corner of the Southeast Quarter of the Southwest Quarter of Section 27, Township 18 South, Range 8 East, SLB&M, said point being on the existing Castle Dale City oundary; thence N 89°44'34" E, 92.89 feet along said existing boundary; thence S 00°15'28" E, 9.72 feet

along said existing boundary; thence N 89°44'34" E, 60.57 feet; thence S 00°46'31" E, 1.28 feet; thence N 89°44'34" E, 613.20 feet to the Quarter Section Line; thence N 89°08'32" E, 532.36 feet; thence N 00°37'23" W, 406.94 feet; thence S 89°08'32" W, 150.00 feet; thence S 00°59'49" E, 326.94 feet; thence S 89°08'32" W, 382.73 feet to the Quarter Section Line; thence S 89°44'34" W, 765.98 feet to the existing Castle Dale City Boundary; thence S 00°46'31" E, 69.00 feet along said existing boundary to the point of beginning.

Containing 3.58 acres, more or less.

Section 4. EFFECTIVE DATE

This ordinance shall take effect immediately upon passage and posting as required.
