RE: Notice of Impending Boundary Action

Lt. Governor Henderson:

On March 17, 2021, the Providence City Council adopted Ordinance 2021-013, an ordinance reaffirming Ordinance 2020-004 an ordinance granting a request to disconnect a 0.40-acre parcel located south of 700 South in the general area of 330 West and legally described as follows:

A PART OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 11 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN, ALSO BEING A PART OF LOT 9, BLOCK 2, PLAT "D" OF THE PROVIDENCE FARM SURVEY.

BEGINNING AT A POINT ON EXISTING PROVIDENCE CITY CORPORATE LIMITS LINE AND ON THE EAST LINE OF THE OF THE LOWER BLACKSMITH FORK CANAL LOCATED NORTH 46°36'59" WEST, A DISTANCE OF 5,047.55 FEET FROM THE SOUTHEAST CORNER OF SAID SECTION 15 AND RUNNING THENCE ALONG SAID CORPORATE LIMITS LINE THE FOLLOWING THREE (3) COURSES: (1) SOUTH 10°42'45" WEST, A DISTANCE OF 63.04 FEET; (2) NORTH 87°37'40" WEST, A DISTANCE OF 346.11 FEET; (3) NORTH 01°47'54" EAST, A DISTANCE OF 56.97 FEET; THENCE SOUTH 84°38'24" EAST, A DISTANCE OF 12.02 FEET; THENCE SOUTH 88°38'01" EAST, A DISTANCE OF 343.88 FEET TO THE POINT OF BEGINNING.

CONTAINING 0.477 ACRES.


This statement certifies that all requirements applicable to the boundary action have been met.
