
NOTICE OF IMPENDING BOUNDARY ACTION

WHEREAS a property owner has requested to be annexed into the Fruitland Special Services District, Duchesne County, Utah and,

WHEREAS the Fruitland Special Service District has agreed to the proposed property annexation and,

WHEREAS at a meeting of Board of Trustees held on November 18, 2021, the Fruitland Special Services District approved the process for legally annexing the proposed property including setting a Public Hearing in December 2021 and,

WHEREAS at a meeting of the Fruitland Special Services District Board of Trustees held on December 16, 2021, the Board held a public hearing regarding the proposed annexation and allowed for public comment or objection to the proposed annexation and,

WHEREAS no public objections were heard and the Board provided for a thirty day period to at least January 17, 2022 for public comment or objections and,

WHEREAS as of January 17, 2022 no public comments or objections have been forthcoming.

NOW THEREFORE in consideration of the foregoing it is hereby resolved as follows:

RESOLVED that the annexation of the Oak Hills subdivision, owner Chris Watkins, as being more fully described by a survey conducted as

Beginning at the South east corner of section 27, township 2, South Range 9 west Uintah Special base and meridian Thence Westerly 1 mile to the Southwest corner of section 27, Thence Northerly 1 mile to the Northwest Corner of Section 27, Thence Easterly 1 mile to the Northeast corner of section 27 Thence Southerly 1 mile to the POINT OF BEGINNING containing 643 acres or 1 square mile

BE IT FURTHER RESOLVED that the Fruitland Special Service District, hereby approves by unanimous vote of the Board of Trustees that the aforementioned property be annexed and shall be considered part of the service district whereby culinary water services may be provided by the Fruitland Special Service District.

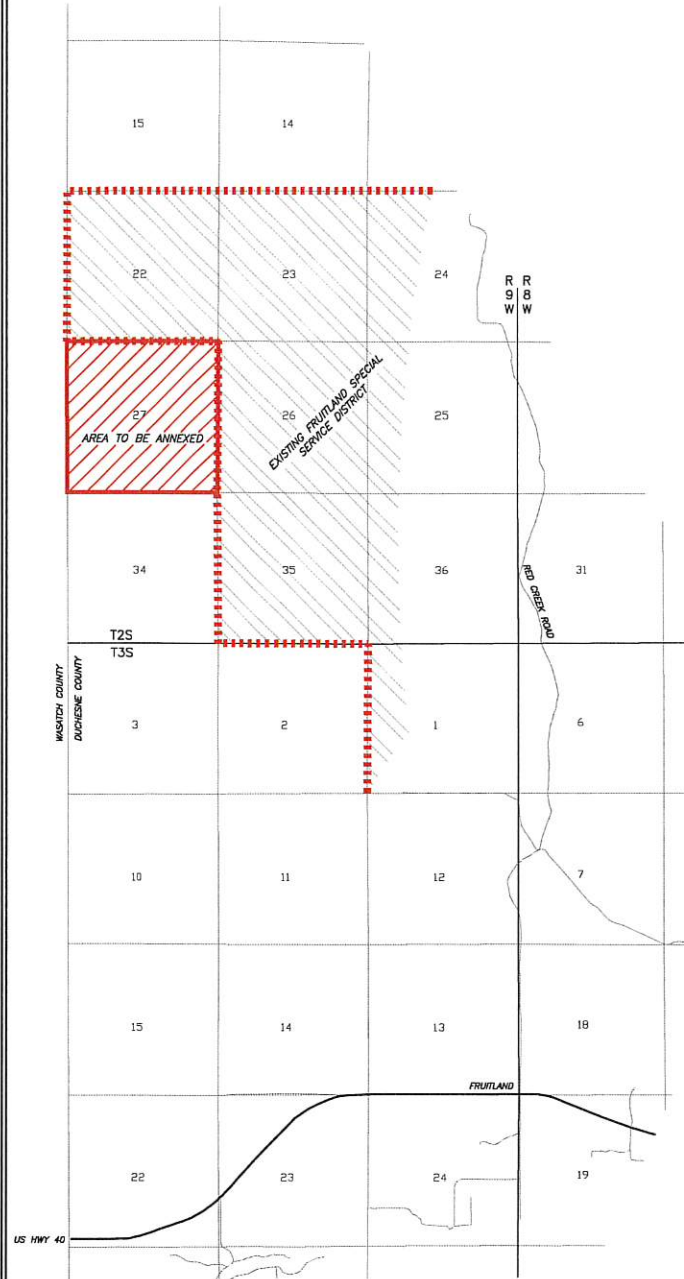
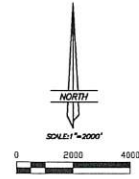
