ORDINANCE NO. 0- 17 -2022

AN ORDINANCE OF EAGLE MOUNTAIN CITY, UTAH, ANNEXING AN AREA OF APPROXIMATELY 161 ACRES, COMMONLY KNOWN AS THE GARDNER FARMS ANNEXATION

PREAMBLE

The City Council of Eagle Mountain City finds that the owners of the real property described herein petitioned for annexation of the real property to the corporate limits of Eagle Mountain City and that all required notices were given and provided to affected entities and others, as required by law.

The real property described herein is an unincorporated area contiguous to the current boundary of Eagle Mountain City, and the annexation will not leave or create an unincorporated island or peninsula.

The City Council finds that it is in the public interest to annex the real property to Eagle Mountain City and has caused a plat of the real property to be prepared by a licensed surveyor.

All public hearings and notices have been completed as a prerequisite to zone the land proposed for annexation as Agriculture.

After public comment and careful consideration, the City Council has determined to annex the referenced property and therefore, finds that it should grant the petitions for annexation with respect to the real property described herein.

BE IT ORDAINED by the City Council of Eagle Mountain City, Utah:

- 1. The real property described on the attached annexation plat, referenced as Exhibit A, is hereby annexed to Eagle Mountain City and the corporate limits of Eagle Mountain City are hereby amended and extended to incorporate the real property described herein.
- 2. The real property described on Exhibit A is hereby zoned Agriculture.
- 3. A certified copy of this Ordinance and an original plat describing the property so annexed, shall be filed with the Utah County Recorder within thirty (30) days after the date this Ordinance is adopted.
- 4. This Ordinance shall be effective on the date of its first posting or publication, whichever occurs first.
- 5. The Mayor or the designee of the Mayor is authorized to notify and implement this annexation with respect to local, county and state governmental entities.

GARDNER FARMS ANNEXATION LEGAL DESCRIPTION

All of the NE 1/4 of Section 34, Township 5 South, Range 2 West, Salt Lake Base and Meridian, more particularly described by Survey as:

Beginning at a point on the westerly line of the current Corporate Limits of Eagle Mountain City being the Northeast Corner of Section 34, T5S, R2W, S.L.B.& M.; thence S0°48'33"W (NAD83) along the Section line and said Corporate Limits 2,653.40 feet to the East 1/4 Corner of said Section; thence N88°38'56"W along the 1/4 Section line 2655.26 feet to a pipe (found) at the Center 1/4 Corner of said Section; thence N0°50'39"E along the 1/4 Section line 2,631.58 feet to the North 1/4 Corner of said Section; thence S89°07'11"E along the Section line 2,653.53 feet to the point of beginning.
