# UTAH LIEUTENANT GOVERNOR HENDERSON NOTICE OF IMPENDING BOUNDARY ACTION DISCONNECTION

The undersigned as Chair of the Erda Council pursuant to Utah Code Ann. §§ 10-2-507 and 67-1a-6.5, hereby submits to the Lieutenant Governor the following Notice of Impending Boundary Action for the Disconnection from Erda City.

## SECTION ONE

On May 19 2022, the Erda City Council adopted an ordinance approving the Disconnection. The boundary action for which an applicable certificate is sought is a disconnection pursuant to Utah Code Ann §10-2-507.

## **SECTION TWO**

The boundaries of the disconnection shall be the area as described on the attached approved final local entity plat.

#### SECTION THREE

Pursuant to Utah Code Ann. § 67-1a-6.5(3)(d) a letter from the Utah State Retirement Office is not required because this is a disconnection and not an incorporation or creation of a local entity that may result in the employment of personnel.

#### SECTION FOUR

Pursuant to Utah Code Ann. § 67-1a-6.5 (3)(e), the Chair of the Erda Council hereby certifies all requirements applicable to this disconnection have been met.

## SECTION FIVE

Pursuant to Utah Code Ann. §10-2-507(3) the effective date of the disconnection is the date on which the Lieutenant Governor issues the Certificate of Disconnection.

# ERDA CITY, UTAH ORDINANCE NO. 22-22

AN ORDINANCE GRANTING DISCONNECTION OF TERRITORY LOCATED AT OR NEAR 16 TO 50 PIER PLACE KNOWN AS THE PIER AT STANSBURY PARK DISCONNECTING APPROXIMATELY 38.15 ACRES FROM ERDA CITY

WHEREAS, the Erda City Council ("Council") met in regular session on May 19th, 2022, to consider, among other things, an ordinance granting disconnection of territory located at or near 16 to 50 Pier Place known as the Pier at Stansbury Park disconnection approximately 38.15 acres from Erda City; and

WHEREAS, residents of the Pier at Stansbury Park filed a petition to disconnect from Erda; and

WHEREAS, the Council finds that the petition ("Petition") for disconnection satisfies all the requirements of Utah law and the Council desires to grant the Petition.

# **NOW THEREFORE, BE IT ORDAINED** by the Council as follows:

- SECTION 1. <u>Findings</u>. The Council hereby find and determine that granting the disconnection as proposed in the Petition is in the best interests of the City and its residents.
  - SECTION 2. Approval of Disconnection. The Council grants the disconnection.
- SECTION 3. <u>Final Local Entity Plat</u>. The Council approves the Final Local Entity Plat as attached hereto as exhibit A and directs that it be filed as required by law
- SECTION 4. <u>Authorized Actions</u>. The Chair and the City Recorder and all other officers and employees of the City are hereby authorized and directed to take, in a timely manner, any and all actions required or advisable to be taken to give effect to the disconnection hereby approved.
- SECTION 5. <u>Effective Date</u>. This Ordinance shall become effective upon publication and as provide by law.
