### NOTICE OF IMPENDING BOUNDARY ACTION

# **ORDINANCE 2022-5**

AN ORDINANCE APPROVING THE CREATION OF A COMMUNITY REINVESTMENT AGENCY, PROVIDING FOR CODIFICATION, INCLUSION IN THE MUNICIPAL CODE, CORRECTION OF SCRIVERNER'S ERRORS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, Gunnison City is a fifth class city of the state of Utah; and

WHEREAS, cities in the State of Utah are authorized to enact ordinances in order to promote and protect the health, safety and welfare of the community; and

WHEREAS, the Gunnison City Council has determined that it is in the best interest of Gunnison City to consider the creation of one or more community reinvestment project areas in accordance with Title 17C of the Utah Code; and

WHEREAS, the City Council deems it desirable that certain community reinvestment activities in Gunnison City be carried out pursuant to the Limited Purpose Local Government Entities - Community Reinvestment Agency Act of the State code.

NOW THEREFORE, BE IT ORDAINED BY THE GUNNISON CITY COUNCIL THAT:

- Section I. The City Council and Mayor of Gunnison City approve the creation of the Community Reinvestment Agency for Gunnison City. The boundaries of such Agency are, and shall always be, coterminous with the boundaries of Gunnison City. The current City Boundary is illustrated in Exhibit A, which is attached hereto and by this reference is made part hereof.
- **Section II.** The Gunnison Municipal Code is amended to include Title 2, Chapter 140 Community Reinvestment Agency, which is hereby created and shall read as follows:

### Title 2.140 Community Reinvestment Agency

#### 2.140.010 Agency Creation

Pursuant to Utah Code § 17C-1-201.5 of the Utah Limited Purpose Local Government Entities - Community Reinvestment Agency Act (the Act), Gunnison City hereby creates and establishes the Gunnison City Community Reinvestment Agency (the Agency) and directs that the requirements of Utah Code § 17C-1-201.5(2) of the act be complied with to finalize the creation and establishment of the agency pursuant to law.

## 2.140.020 Agency Board

Pursuant to Utah Code § 17C-1-203 of the act, the governing body of the agency shall be a board consisting of the current members of the community legislative body, namely, the members of the City Council of Gunnison City.

#### 2.140.030 Agency Powers and Duties

The Agency is authorized to enter into agreements generally in connection with urban renewal, economic development, community development, and community reinvestment matters as

provided in the Act and shall have the power to transact the business of a community reinvestment agency and also to exercise all the powers, rights, duties, and privileges set forth and provided for in the Act and any successor or replacement law or act, and as the same may from time to time be amended. All other provisions of applicable Utah state law, as the same may from time to time be amended, are hereby adopted by this reference as if fully set forth herein.


- **Section III.** Contrary Provisions Repealed. Any and all other provisions of the Gunnison City Municipal Code that are contrary to the provisions of this Ordinance are hereby repealed.
- Section IV. Codification, Inclusion in the Code, and Scrivener's Errors. It is the intent of the City Council that the provisions of this ordinance be made part of the Municipal Code of Gunnison City, Utah as adopted, that sections of this ordinance may be re-numbered or re-lettered, that the word ordinance may be changed to section, chapter, or other such appropriate word or phrase in order to accomplish such intent regardless of whether such inclusion in a code is accomplished. Sections of the ordinance may be re-numbered or re-lettered. Typographical errors which do not affect the intent of this ordinance may be authorized by the City without need of public hearing by its filing a corrected or re-codified copy of the same with the City Recorder.
- **Section V.** Severability. If any section, phrase, sentence, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.
- Section VI. Posting and Effective Date. Prior to 5:00 p.m. on June 15, 2022, the City Recorder shall: (a) deposit a copy of this ordinance in the official records of the City; and (b) post a copy of this ordinance in three places within the City. This ordinance shall become effective at 5:00 p.m. on June 15, 2022.
