### ORDINANCE NO. 2021-34

AN ORDINANCE OF THE CITY COUNCIL OF FARMINGTON CITY PROVIDING FOR THE DISCONNECTION OF CERTAIN REAL PROPERTY LOCATED AT APPROXIMATELY 825 WEST GLOVERS LANE WITHIN THE CITY OF FARMINGTON

WHEREAS, Farmington City received petition requesting disconnection from Teresa Hill, the owner of property located at approximately 825 West Glovers Lane (Davis County Parcel I.D. # (08-079-0045); and

WHEREAS, the City Council on October 5, 2021, held a public hearing regarding the request for disconnection from the municipal boundaries of the City; and

WHEREAS, the City Council of Farmington City, based upon the request from the property owner, now desires to permit the property to disconnect from the City;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF FARMINGTON CITY, STATE OF UTAH, AS FOLLOWS:

- Section 1: Disconnection. That certain real property more particularly identified in Exhibit A, attached hereto and incorporated by reference, is hereby disconnected from the municipal boundaries of Farmington City. City staff is hereby directed, in accordance with the provisions of *Utah Code Ann.* § 10-2-507, to work with the owner of the affected property to provide a notice of an impending boundary action and a copy of an approved final local entity plat to the Office of the Lt. Governor of the State of Utah within 30 days of the date of this Ordinance. City staff is hereby directed to take all further action required by law to complete the disconnection of the requested property.
- Section 2: Associated Costs. The City Council hereby directs the City staff should assess all costs of the preparation of the local entity plat to the property owner requesting disconnection and shall file the local entity plat with the Lt. Governor's office only upon receipt of the costs of the preparation of the plat.
- Section 3: Severability. If any section, part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts and provisions of this Ordinance shall be severable.
- Section 4: <u>Effective Date</u>. In accordance with state law this ordinance shall be deemed effective upon its approval and the effective date of disconnection of the property shall be as set forth in *Utah Code Ann.* § 10-2-507.

### LAND BOUNDARY DESCRIPTIONS

#### DISCONNECT PARCEL DESCRIPTION

BEGINNING AT A CORNER OF THE CORPORATE LIMITS OF FARMINGTON CITY, SAID CORNER IS SOUTH 0°29'51" EAST 454.50 FEET ALONG THE QUARTER SECTION LINE AND NORTH 89°52'30" WEST 916.01 FEET FROM THE CENTER QUARTER OF SECTION 25, TOWNSHIP 3 NORTH, RANGE 1 WEST, SALT LAKE BASE AND MERIDIAN (DAVIS COUNTY SURVEYOR'S ROUND BEARING BASE), AND RUNNING THENCE SOUTH 89°52'30" EAST 21.96 FEET ALONG A PROJECTED LINE OF SAID CORPORATE LIMITS; THENCE SOUTH 00°12'15" WEST 83.04 FEET TO A SOUTHERLY LINE OF SAID CORPORATE LIMITS; THENCE ALONG THE LINES OF SAID CORPORATE LIMITS THE FOLLOWING THREE (3) COURSES: 1) NORTH 89°52'30" WEST 266.85 FEET, 2) NORTH 00°00'00" EAST 83.04 FEET, 3) SOUTH 89°52'30" EAST 245.19 FEET TO A CORNER OF SAID CORPORATE LIMITS AND TO THE POINT OF BEGINNING.

PARCEL CONTAINS 0.509 ACRES.
