NOTICE OF AN IMPENDING BOUNDARY ACTION AND REQUEST FOR CERTIFICATION BY THE CITY OF HYDE PARK, UTAH

To Lt Governor Deidre M. Henderson

Pursuant to the provisions of Utah Code Ann. §10-2-418, §10-2-425, and § 67-1a-6.5, the City of Hyde Park, Cache County, Utah (the "City"), a body corporate and politic of the State of Utah, hereby gives notice to the Utah Lieutenant Governor, that on Aug 10, 2022, the City Council adopted an Ordinance approving the annexation of certain property into the boundaries of the City.

Accompanying this Notice is a copy of the Ordinance approving the annexation of certain property into the boundaries of the City of Hyde Park, Utah, together with a copy of an approved final local entity plat showing the as-modified boundaries of the City, prepared, and certified by a licensed surveyor and approved by the Utah County Surveyor consistent with §17- 23-20.

Hyde Park City Ordinance 2022-19

An Ordinance Annexing 161.78 acres (parcels 04-049-0004, 04-049-0002, & 04-001-0006) pursuant to Section 10-2-407, U.A.C as Requested by Scott Baker & 2 Brothers Inc.

The City Council of Hyde Park, Utah, in a regular meeting, at which lawful notice was given, finds that the City adopt an ordinance annexing 161.78 acres more or less of property, into the Hyde Park City corporate limits.

Be if therefore ordained by the Hyde Park City Council that the 161.78 acres more or less of property described as follows be annexed into Hyde Park City:

A PART OF THE SOUTHWEST QUARTER OF SECTION 1 AND A PART OF THE NORTHEAST QUARTER AND THE NORTHWEST QUARTER OF SECTION 12, TOWNSHIP 12 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN BEING DESCRIBED AS FOLLOWS:

THE NORTH HALF OF THE NORTHEAST QUARTER OF SAID SECTION 12. CONTAINING 80.71 ACRES

ALSO: THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 12. CONTAINING 40.64 ACRES.

ALOS: THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 1. CONTAINING 40,43 ACRES.

Effective Date. This ordinance shall become effective upon passage by the City Council of Hyde Park City, Utah.
