## A RESOLUTION OF THE GOVERNING BOARD OF THE BONA VISTA WATER IMPROVEMENT DISTRICT ANNEXING REAL PROPERTY IN PLEASANT VIEW

WHEREAS, Bona Vista Water Improvement District ("District") is an improvement district duly organized and existing under the laws of the State of Utah; and

WHEREAS, a petition has been filed by John C. Lott to have real property (parcel number 19-016-0110) annexed into the District; and

WHEREAS, the Board certified the petition and the proposed annexation has been noticed in accordance with state law; and

WHEREAS, the Board finds approving this annexation is in best interest of the District;

**NOW THEREFORE,** be it resolved by the Board of Trustees of the Bona Vista Water Improvement District, that the following real property is hereby annexed into the District and shall receive culinary water under the same fees, rules, and regulations applicable to the District.

### Parcel # 19-016-0110

A PART OF THE SOUTHEAST QUARTER OF SECTION 25, TOWNSHIP 7 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN.

BEGINNING AT A POINT ON THE WESTERLY RIGHT-OF-WAY LINE OF HIGHWAY 89, BEING 1612.12 FEET NORTH 89°16'08" WEST ALONG THE SECTION LINE TO SAID WESTERLY LINE OF HIGHWAY 89; AND 110.12 FEET SOUTH 29°12'51" EAST ALONG SAID WESTERLY LINE FROM THE EAST QUARTER CORNER OF SAID SECTION 25, RUNNING THENCE SOUTH 29°12'51" EAST (S 29°35'00" E REC.) 161.37 FEET ALONG SAID HIGHWAY RIGHT-OF-WAY LINE; THENCE NORTH 89°16'08" WEST 933.08 FEET (N 89°36'11" W 933.21' REC.) TO THE EASTERLY RIGHT-OF-WAY LINE OF THE

O.S.L.R.R; THENCE NORTH 25°28'10" WEST 156.27 FEET (N 26°10'00" W 156.60' REC.) ALONG SAID EASTERLY RIGHT-OF-WAY LINE; THENCE SOUTH 89°14'41" EAST 921.59 (S 89°36' 11" E 922.97' REC.) FEET TO THE POINT OF BEGINNING.
