ORDINANCE 09-06-2022

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO NEPHI CITY AND ESTABLISHING ZONING CLASSIFICATION FOR SAID PROPERTY.

BE IT ORDAINED BY THE CITY COUNCIL OF NEPHI CITY, UTAH:

SECTION I. That the following described real property be, and the same is hereby annexed to Nephi City, Utah, the corporate limits of said city are hereby extended to include said described property, and said property is hereby declared to be part of Nephi City and shall henceforth be subject to all of the ordinances and regulations thereof, and that the description of the boundaries of Nephi City be amended to include the following property to-wit:

Racoon Eye Annexation See Exhibit 1

SECTION II. That the territory annexed under Section I above, is hereby classified into the ID-3 Light Industrial zone as shown on Exhibit 2.

ANNEXATION BOUNDARY DESCRIPTION

That portion of the SW¼NE¼ and SE½NW¼ and SW½SE¼ and SE½SW¼ of section 5 Township 13 South Range 1 East SLB&M more particularly described by metes and bounds as follows:

Beginning at a point on the South Right-of-Way line of Highway 132, said point lies 279.21 feet S.89'40'59"E. along said Right-of-Way line and 678.33 feet S.00'28'32"E. from the Northeast corner of the Southwest quarter of Section 5, Township 13 South, Range 1 East, Salt Lake Base and Meridian, thence N. 89'40'59" W. 574.97 feet along said South Right-of-Way line of highway 132, thence N. 00'23'47" W. 833.14 feet along an old fence line to a fence corner, thence S. 89'35'34" E. 574.41 feet along an old fence line to a fence corner, thence S. 00'26'07" E. 832.24 feet along an old fence line to said South Right-of-Way line of highway 132 to the point of beginning. The above described parcel of land contains 478,492 square feet in area or ±10.985 acres.
