RESOLUTION ANNEXING LAND INTO EAST DUCHESNE CULINARY WATER IMPROVEMENT DISTRICT

November 9, 2022

WHEREAS the East Duchesne Culinary Water Improvement District is a water improvement district, duly organized under the laws of the State of Utah, in Duchesne County, Utah, and,

WHEREAS THE East Duchesne Culinary Water Improvement District was created by the Duchesne County, Utah Board of Commissioners by Resolution dated February 14, 1978 and,

WHEREAS in the year 2021, two petitions were received by the District Board requesting that lands be added to the District by Annexation. One petition as for land north but adjacent to the existing District and the other for land south but adjacent to the existing District, and,

WHEREAS, the petitions both met the signature and assessed value requirements for Annexation Petitions established by Utah Code in Section 17B-1 et seq, and,

WHEREAS, the Board reviewed the two petitions and approved them and certified that approval, and delivered copies to the contact sponsors and mailed written Notice of the proposed Notice to the Duchesne Count Clerk and Attorney with a copy of the petitions and the certifications, and,

WHEREAS the Duchesne County Clerk and Attorneys Office have approved the proposed Annexation, and,

WHEREAS, a Public Hearing was scheduled, the required Notices of the Hearing were mailed to all persons shown on the County land records as owning land within the proposed area to be annexed and the Hearing was held September 14, 2022, and,

WHEREAS the Board heard comments and answered questions from the public and land

owners and more than 30 days have passed since the Hearing and no protests to the Annexation have been filed with the Board, and,

WHEREAS the legal requirements for approving the Annexation have been met, and the Board approves and adopts the following resolution:

NOW THEREFORE it is hereby resolved by the governing Board of the East Duchesne Culinary Water Improvement District, that the following described lands are annexed into the East Duchesne Culinary Water Improvement District:

North Annexation Area:

Description of portion to be annexed in T2S, R5W, U.S.B.&M: Beginning at the Southeast Corner of Section 36, Township 2 South, Range 5 West, Uintah Special Base and Meridian; Thence Westerly 3 Miles to the Southwest Corner of Section 34; Thence Northerly 1 Mile to the Northwest Corner of Section 34; Thence Westerly 1 Mile to the Southwest Corner of Section 28; Thence Northerly 1 Mile to the Northwest Corner of Section 28; Thence Easterly 3 Miles to the Northeast Corner of Section 26; Thence Southerly 1 Mile to the Southeast Corner of Section 26; Thence Easterly 1 Mile to the Northeast Corner of Section 36; Thence Southerly 1 Mile to the Northeast Corner of Section 36; Thence Southerly 1 Mile to the POINT OF BEGINNING, containing 3833 acres, or 6 sq. miles.

Description of portion to be annexed in T3S, R5W, USBM: Beginning at the North 1/4 Corner of Section 1, Township 3 South, Range 5 West, USBM; Thence Southerly 1 Mile along the Center Section line to the South 1/4 Corner of said Section 1; Thence Westerly ½ Mile to the Southeast Corner of Section 2; Thence Westerly 1 Mile to the Southwest Corner of Section 2; Thence Northerly 1 Mile to the Northwest Corner of Section 2; Thence Easterly 1 Mile to the Northeast Corner of Section 2; Thence Easterly 1 Mile to the Northeast Corner of Section 2; Thence Easterly 1/2 Mile to the POINT OF BEGINNING, containing 960 acres, or 1.5 sq. miles.

Notice is hereby given that the 14th day of September, 2022 has been set by the Board of the East Duchesne Culinary Water Improvement District as the day for a public hearing to propose the annexation of the North Annexation Area and the South Annexation Area described below:

NORTH ANNEXATION AREA:

DESCRIPTION OF PORTION TO BE ANNEXED IN T2S, R5W, U.S.B.&M:

Beginning at the Southeast Corner of Section 36, Township 2 South, Range 5 West, Uintah Special Base and Meridian;

Thence Westerly 3 Miles to the Southwest Corner of Section 34; Thence Northerly 1 Mile to the Northwest Corner of Section 34; Thence Westerly 1 Mile to the Southwest Corner of Section 28; Thence Northerly 1 Mile to the Northwest Corner of Section 28; Thence Easterly 3 Miles to the Northeast Corner of Section 26; Thence Southerly 1 Mile to the Southeast Corner of Section 26; Thence Easterly 1 Mile to the Northeast Corner of Section 36; Thence Southerly 1 Mile to the POINT OF BEGINNING, containing 3833 acres, or 6 sq. miles.

Thence Southerly 1 Mile along the Center Section line to the South 1/4 Corner of said Section 1; Thence Westerly ½ Mile to the Southeast Corner of Section 2; Thence Westerly 1 Mile to the Southwest Corner of Section 2; Thence Northerly 1 Mile to the Northwest Corner of Section 2; Thence Easterly 1 Mile to the Northeast Corner of Section 2; Thence Easterly 1/2 Mile to the POINT OF BEGINNING, containing 960 acres, or 1.5 sq. miles.

SOUTH ANNEXATION AREA:

Thence Southerly 1 Mile to the Southeast Corner of Section 23; Thence Westerly 1 Mile to the Southwest Corner of Section 23; Thence Northerly 1 Mile to the Northwest Corner of Section 23; Thence Easterly 1 Mile to the POINT OF BEGINNING, containing 640 acres, or 1 sq. miles.

The above described lands are not within the current service boundaries of the District.

The public hearing will be held on September 14th, 2022, at the Duchesne Administration Building located at 734 N Center Street, Duchesne, UT at 7:00 pm.

The estimated financial impact of this annexation on future taxes would be the tax levy established by the Board for property located within the district. Historically that levy has been \$0.00. The operation of the District has been funded from the sale of water. Property owners within the above described areas may file a written protest with the District Board within 30 days after the public hearing.
