

Salem City is seeking a certificate of annexation of the Office of the Lt. Governor

This letter serves as filing a notice of impending boundary action of the Water Canyon Annexation, for the annexation of property located at approximately 10029 South 600 East, in unincorporated Utah County into the boundaries of Salem City (a city within Utah County) by petition under UCA \$10-2-403/\$10-2-418. For reference, Utah County is a county of the 2nd Class.

The proposed annexation consists of four parcels, totaling 4.29 acres.

WATER CANYON ANNEXATION

Beginning at a point on the centerline of 600 East Street, said point being 1317.01 feet South 89°27'09" West and 15.88 feet South 0°32'51" East from the East Quarter Corner of Section 7, Township 9 South, Range 3 East, Salt Lake Base & Meridian; thence North 89°18'02" East 26.96 feet to the Southwest Corner of Lot 6, Loafer View Estates Subdivision; thence North 62°59'15" East 21.36 feet along the south line of said Lot 6; thence North 14°24'15" East 1.10 feet along the east line of said lot; thence North 89°24'51" East 167.92 feet to a point at the centerline of the Strawberry High Line Canal and the existing Salem City boundary; thence along said City boundary the following three (3) courses: South 22°23'31" East 391.14 feet to a point on a 107.77 foot radius curve to the right; thence along the arc of said curve 147.59 feet having a central angle of 78°28'00" (chord bears South 16°50'29" West 136.32 feet); thence South 56°04'29" West 379.92 feet to a point on the center line of said 600 East Street; thence North 0°41'58" West 691.40 feet along said centerline to the point of beginning.

AN ORDINANCE ANNEXING AND ZONING PROPERTY KNOWN AS WATER CANYON ANNEXATION

WHEREAS, on October 10, 2023, a petition for annexation was filed with Salem City by the Central Utah Water Conservancy District, Rebecaa Barney, and Utah Power and Light Company ("Petitioners"), the owners of property representing a majority of the assessed valuation of real property, hereinafter described, which property lies contiguous to the corporate limits of Salem City; and

WHEREAS, the Petitioners have submitted an accurate plat of said territory and have filed the same in the office of the Salem City Recorder (attached as an exhibit hereto);

WHEREAS, on November 1, 2023, the Salem City Council accepted the petition for further consideration and the City certified it to the Utah County Boundary Commission, pursuant to Utah Code Ann. §10-2-405, on December 8, 2023;

WHEREAS, the Salem City Recorder has certified that the petition complies with the requirements of Utah Code Ann. §10-2-403, as they pertain to annexations;

WHEREAS, publication of the certification took place on December 8, 2023, on the Utah Public Notice website, the Salem City website, and was posted at various other public posting locations throughout Salem City;

WHEREAS, no protests were received concerning the annexation petition;

WHEREAS, a public hearing was held before the Salem City Council on Wednesday, March 6, 2024, pursuant to Utah Code Ann. §10-2-407, with notice having taken place in accordance with said section; and

WHEREAS, at the public hearing, the Council heard comments and discussion concerning the annexation and zoning of the property;

NOW THEREFORE, be it ordained and enacted by the Salem City Council as follows:

Section 1. Annexation. Pursuant to Utah Code Ann. §10-2-402(1)(c), the Salem City Council hereby consents to the annexation so as to include and incorporate within said City limits the following described land: See attached Exhibit.

Section 2. Zoning Classification.

Pursuant to Salem City Code § 14-1-030, the property is hereby zoned as follows: A-1 and PF (Public Facilities).

Section 3. Not Part of Municipal Code. This ordinance shall not become part of the Salem City Municipal Code.

Section 4. Effective Date. This ordinance shall become effective upon posting.
