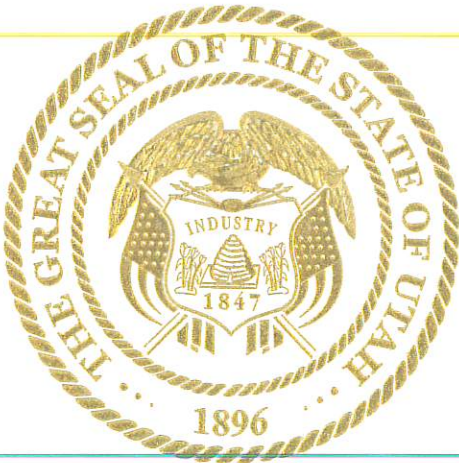

RESOLUTION NO. 05-28-2024-01

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE SOUTH VALLEY SEWER DISTRICT AUTHORIZING A CHANGE IN THE NAME OF THE DISTRICT TO THE JORDAN BASIN IMPROVEMENT DISTRICT PURSUANT TO THE PROVISIONS OF *UTAH CODE ANNOTATED SECTION 17B-1-105*

WHEREAS, the Board of Trustees of the South Valley Sewer District has determined that it will promote the public interest to change the name of the South Valley Sewer District (the "District") to the Jordan Basin Improvement District; and

WHEREAS, the Board of Trustees has held a public hearing and has provided the opportunity to receive public input from anyone desiring to comment on the name change; and

WHEREAS, the District now desires to formally change the name of the District to the Jordan Basin Improvement District;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF SOUTH VALLEY SEWER DISTRICT AS FOLLOWS:

Section 1. Name Change. The name of the South Valley Sewer District is hereby changed and shall from the effective date as set forth in Section 2, below, be the Jordan Basin Improvement District. The District staff is hereby directed and authorized to take all actions necessary with the Lieutenant Governor's Office and any other entities to formally change the name of the District.

Section 2. Effective Date of Name Change. The name change of the District shall be effective upon the issuance of the Lieutenant Governor's Certificate of Name Change pursuant to *Utah Code Annotated* Section 67-1A-6.7, and the recording of the Certificate of Name Change and a certified copy of this Resolution with the County Recorders for Utah County and Salt Lake County.


Section 3. Severability. If any section, part or provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts and provisions of this Resolution shall be severable.


Section 4. Effective Date. This Resolution shall become effective immediately upon its passage, with the name change becoming effective as stated herein.

Notice of Public Hearing on a Proposed Name Change of the South Valley Sewer District.

The Board of Trustees for the South Valley Sewer District hereby gives notice that it will hold a public hearing to receive public comment in regards to a change in the District's name on Tuesday, May 28th at 7:00 a.m. at the South Valley Sewer District Office, 1253 West Jordan Basin Lane, Bluffdale, Utah

Under consideration is a proposal to change the name of the District from South Valley Sewer District to Jordan Basin Improvement District. This change is to help eliminate confusion with our neighboring entity, South Valley Water Reclamation Facility, to reduce confusion surrounding South Valley Sewer District and Jordan Basin Water Reclamation Facility (JBWRF is owned and operated by SVSD), and to provide clarity and unity within the District. The District is following the process and procedure for such a change as outlined in the Utah Code 17B-1-105.

The District is holding this public hearing as required by State Code to receive public comment. In compliance with the Americans with Disabilities Act, persons needing communicative aids and services for the meeting should call the District at 801-571-1166 giving at least 48 hours advance notice of their needs.
