7	RECITALS:

9	On October 17, 2023, the Municipal Council approved a resolution of intent to consider
10	concurring with Utah County on the common boundary between Provo and Orem near the
11	intersection of 1030 East in Orem and 2550 North in Provo as shown in Exhibit A; and
12	
13	No written protests to the adjustment have been filed with the City Recorder by the owners
14	of private real property that are located within the relevant area proposed for; and
15	
16	This action was previously approved in Ordinance 2024-8 on February 15, 2024. For
17	technical reasons, that previous ordinance needs to be rescinded and the adjustment approved
18	again; and
19	
20	The Orem City Council has considered or will also consider an ordinance to approve the
21	agreed upon common boundary; and
22 23	On June 4, 2024 the Municipal Council held a duly noticed public hearing to receive public
23 24	comment and ascertain the facts regarding this matter, which facts and comments are found in the
25	hearing record; and

27	After considering the facts and comments presented to the Municipal Council, the Council
28	finds that (i) the City should concur with Utah County on the common boundary as legally
29	described in Exhibit A between Provo City and Orem and (ii) such action furthers the health,
30	safety, and general welfare of the citizens of Provo City.

32	THEREFORE, the Municipal Council of Provo City, Utah ordains as follows:

34	PART I:

36	The Provo Municipal Council concurs with Utah County on the common boundary
37	between Provo City and Orem shown on the attached Exhibit A.

39	PART II:
40	Ordinance 2024-8, previously approved on February 15, 2024, is rescinded.


4142 <u>PART III:</u>

A. If a provision of this ordinance conflicts with a provision of a previously adopted ordinance, this ordinance prevails.

B. This ordinance and its various sections, clauses, and paragraphs are severable. If any part, sentence, clause, or phrase is adjudged to be unconstitutional or invalid, the remainder of the ordinance is not affected by that determination.

C. This ordinance shall be uncodified.

D. This ordinance shall take effect immediately after it has been posted or published in accordance with Utah Code 10-3-711, presented to the Mayor in accordance with Utah Code 10-3b-204, and recorded in accordance with Utah Code 10-3-713. Notwithstanding the foregoing, if the Orem Municipal Council does not pass an ordinance approving the boundary line adjustment described herein by January 31, 2025, this ordinance shall expire and shall be null and void.
