RESOLUTION #2024- 05 - 04

A RESOLUTION DESIGNATING OFFICIAL NAME OF MUNICIPALITY TO EMIGRATION CANYON

WHEREAS, previously, Emigration Canyon was a metro township under Utah Code Ann. § 10-3c et seq; and

WHEREAS, during the 2024 legislative session, the Utah Legislature passed H.B. 35, which converted metro townships into cities and towns based on their populations effective May 1, 2024; and

WHEREAS, now that Emigration Canyon is classified as a city under Utah Code Ann. § 10-2-301; and

WHEREAS, Emigration Canyon desires to designate its name as a municipality to "Emigration Canyon" pursuant to Utah Code Ann. § 10-1-118.

NOW, THEREFORE, THE FOLLOWING IS RESOLVED BY THE EMIGRATION CANYON CITY COUNCIL EFFECTIVE IMMEDIATELY:

Section I: that its municipal name is Emigration Canyon; and

Section II: that this Resolution be filed with the Utah Lieutenant Governor's Office with a Notice of Impending Name Change to receive a Certificate of Name Change; and

<u>Section III:</u> that a certified copy of this Resolution approving the name change, the Notice of Impending Name Change, and the Certificate of Name change be submitted to the Salt Lake County Recorder.

Lt. Governor Henderson:

During the 2024 Legislative Session, the Utah Legislature passed H.B. 35 Metro Township Modifications and the Governor signed the bill on March 20, 2024. H.B. 35 legislatively converted existing metro townships to towns or cities, depending on population, and became effective on May 1, 2024. On that date, the Emigration Canyon Metro Township converted to a city of the fifth class.²

As required by Utah law, this letter serves as a Notice of Impending Name Change of Emigration Canyon Metro Township to "Emigration Canyon." The entirety of Emigration Canyon is within Salt Lake County, Utah and this letter certifies that the Emigration Canyon City Council have met all requirements applicable to a name change.

Attached to this letter is a copy of the Resolution approving the name change and the public notice of the proposed name change for the May 28, 2024, City Council meeting.
