

ORDINANCE 2024-254

AN ORDINANCE ANNEXING AN AREA OF APPROXIMATELY 0.30 ACRES TO HENEFER TOWN, UTAH

THE Town Council of Henefer Town finds that the owners of the real property described herein petitioned for annexation of the real property to the corporate limits of Henefer Town and that all required notices were given an provided to affected entities and others as required by law; and

THE real property described herein is an unincorporated area contiguous to the current boundary of Henefer Town and annexation will not leave or create an unincorporated island or peninsula; and

THE Town Council finds that it is in the public interest to annex the real property to Henefer Town and has caused a plat of the real property to be prepared by a licensed surveyor; and

AFTER public comment and careful consideration the Town Council has determined to annex the referenced property and therefore, finds that it should grant the petition for annexation with respect to the real property describe herein annex the property to Henefer Town.

BE IT ORDAINED by the Town Council of Henefer Town, Utah;

- 1. The real property described on Exhibit A is hereby annexed to Henefer Town and the corporate limits of Henefer Town are hereby amended and extended to incorporate the real property described, with the following conditions on annexation:
 - a. That the annexed ground be designated as zone RA-1;
 - b. That all lot lines of the annexed and adjoining parcels be adjusted such that no peninsulas, islands or holding strips remain, on or before July 2, 2024; and
 - c. That if the current or future owners of the property fail to meet these conditions, that the annexed parcel revert to the County
- 2. A certified copy of this ordinance and an original plat describing the property so annexed, shall be filed with the Summit County Recorder withing thirty (30) days after the date this ordinance is adopted.
- 3. A notice of Adoption of Annexation Ordinance shall be filed with the Utah Lieutenants Governor's office as required by law.
- 4. A certified copy of this ordinance, certification from the Office of the Lieutenant Governor of Utah that a copy of the annexation plat describing the property annexed and a Notice of Annexation pursuant to Utah Code Ann. Section 10-1-116, shall be filed with the Utah State Tax Commission prior to August 31, 2024.
- 5. This ordinance shall be effective on the date of its first publication.
- 6. The Mayor or designee of the Mayor is authorized to notify and implement this annexation with respect to local, county and state governmental entities.



EXHIBIT "A"


A tract of land being part of the Northeast 1/4 of Section 9, Township 3 North, Range 4 East, Salt Lake Base and Meridian. Having a Basis of Bearing of North 00° 22' 35" East between the Southeast and Northeast Corners of said Section 9, described as follows:

Beginning at a point which is North 00° 22' 35" East 3263.27 feet along the Section Line and West 171.55 feet from the Southeast Corner of said Section 9 (said point being on the original Town Boundary Line) and running thence South 49° 33'07" West 1.25 feet along the Foust Annexation Boundary to the center of an irrigation canal; the next (3) courses are along said irrigation canal, thence North 66° 30' 56" West 81.80 feet; thence North 65° 55' 46" West 144.16 feet; thence North 63° 08' 24" West 83.40 feet more or less to the southerly annexation boundary line for the Pioneer Crossing Subdivision; the next (2) courses are along said Pioneer Crossing Annexation Boundary Line thence North 72° 32' 35" East 12.77 feet; thence North 12° 02' 31" East 76.38 feet more or less to a point on the original Town Boundary Line; thence South 50° 50' 12" East 327.45 feet along said boundary line to the POINT OF BEGINNING; said described tract containing 0.30 Acres, more or less.
