### **ORDINANCE #03-2025**

# AN ORDINANCE ANNEXING PROPERTY INTO SPRINGVILLE CITY, WHICH ANNEXATION IS KNOWN AS THE S & K ANNEXATION

WHEREAS, a petition has been filed with the Springville City Council by Shawn and Karman Shultz, the owners of real property located at approximately 1520 East 1200 South, Springville, Utah, comprising 8,548 square feet or 0.196 acres which property lies contiguous to the corporate limits of Springville City and is more specifically described under Section 1 below and on the map attached as Exhibit A (the "Property"); and

WHEREAS, the petitioners have also submitted an accurate plat of said territory and have filed the same in the office of the Springville City Recorder; and

WHEREAS, the Springville City Recorder has certified that the petition complies with the requirements of Sections 10-2-403 and 405 of the Utah Code as it pertains to the annexation; and

WHEREAS, Springville City has accepted the petition and certified it to the Utah County Boundary Commission pursuant to Section 10-2-405 of the Utah Code; and

WHEREAS, a notice of the certification was done pursuant to Section 10-2-406 of the Utah Code; and

WHEREAS, Springville City has studied the impact this annexation would have on the City, including utility impacts, infrastructure, and transportation; and

WHEREAS, no timely protests were received concerning the annexation petition; and

WHEREAS, a public hearing was held before the Springville City Council on February 04. 2025, pursuant to Section 10-2-407 of the Utah Code, with notice having taken place in accordance with said section; and

WHEREAS, on December 10, 2024, the Planning Commission held a properly noticed public hearing to consider whether the Property should be zoned with the R1-10 zoning district and recommended that the property should be zoned R1-10; and

WHEREAS, the property petitioned for annexation is undeveloped, and has development concepts consistent with the Springville City Comprehensive General Plan; and

WHEREAS, after holding the public hearing on February 04, 2025, the Springville City Council finds that: (1) all the necessary requirements of the Utah Code and the City's annexation policy of the General Plan for the Property to be annexed into Springville City have been met; (2) it's in the best interests of the City to annex the property; and (3) the Property should be zoned with the R1-10 zone and the zoning map should be amended to reflect the

zoning of the Property.

NOW, THEREFORE, BE IT RESOLVED by the Council of Springville City, Utah:

**SECTION 1.** The boundaries of Springville City are hereby extended so as to include and incorporate within the said City limits the following real property located in Utah County:

BEGINNING AT A POINT WHICH IS SOUTH 89'43'18" WEST ALONG THE SECTION LINE A DISTANCE OF 1007.88 FEET AND NORTH 00"6'42" WEST 1590.26 FEET FROM THE SOUTHEAST CORNER OF SECTION 3, TOWNSHIP 8 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN, SAID POINT BEING ON THE INTERIOR EASTERLY LINE OF WINGET ANNEXATION, ON FILE WITH THE OFFICE OF THE UTAH COUNTY RECORDER AS MAP FILING NO. 5583, AND RUNNING THENCE ALONG SAID WINGET ANNEXATION THE FOLLOWING THREE (3) COURSES, 1) NORTH 00'59'00" EAST 39.85 FEET, 2) EAST 165.00 FEET, 3 SOUTH 59.26 FEET TO THE NORTHERLY LINE OF THE MAPLETON CITY BOUNDARY, THENCE SOUTH 89'44'58" WEST ALONG SAID NORTHERLY LINE A DISTANCE OF 48.31 FEET, THENCE NORTH 60'10'00" WEST 14.40 FEET; THENCE SOUTH 01"15'37" WEST 1.57 FEET; THENCE NORTH 83'37'50" WEST 69.02 FEET; THENCE NORTH 80'01'07" WEST 36.81 FEET TO THE POINT OF BEGINNING.

CONTAINS 8,548 SQUARE FEET, MORE OR LESS.

**SECTION 2.** That the Property, as described in Section 1 and shown on the map attached as Exhibit A is hereby zoned R1-10 and the zoning map should be amended to incorporate the zoning of the Property.

**SECTION 3**. Springville City staff is directed and authorized to follow all state annexation laws to finalize this annexation.

SECTION 4. This Ordinance shall not become part of the Springville City Municipal Code.

**SECTION 5**. This ordinance shall take effect upon the first publication or posting as required by law.








